SLA is staffed by two full time Attorneys in addition to 2nd and 3rd year Law Clerks who handle various cases under the supervision of the Attorneys.

There are specific guidelines and limitations concerning what legal matters we can handle and to what extent we can pursue a case. If you would like to set up an appointment to meet with one of our staff, please call or come by the office to schedule your appointment. An Attorney or Law Clerk will be assigned to meet with you to discuss your case. We do not schedule same day appointments and we cannot give legal advice over the phone.
